## Emergency Rental Assistance Applications are open for Renters and Landlords

Charleston County citizens struggling to make rent and utility payments due to the COVID-19 pandemic can now apply for aid. The Emergency Rental Assistance Program (ERAP) is accepting applications from renters and landlords. Applications can be found here: <https://charlestoncounty.org/erap/index.php>.

Citizens needing help to fill out the application can call 855-452-5374 Monday-Friday from 8:30 a.m. - 5 p.m.

The funding is part of \$25 billion allocated through the federal Consolidated Appropriations Act to help states and local governments with populations over 200,000 establish ERAP programs. Funding will go to help low-income renter households at risk of experiencing homelessness or housing instability, and where one or more household members qualify for unemployment benefits or have experienced financial hardship due, directly or indirectly, to the pandemic. The priority will be to cover housing-related payments that are past due. Applications will be accepted from either the renter or a landlord on behalf of a renter meeting eligibility requirements.
