## McClellanville Library Temporary Move for Renovations:

The McClellanville Library closed on Friday, Dec. 22 to undergo renovations as part of the ongoing referendum-funded project. The library will receive an interior refresh including new paint, carpet, and furniture. Once construction is underway, the renovations are expected to take several months to complete. The designs were created by Liollio Architecture.

While the building is closed, CCPL will continue to provide limited library services in McClellanville. Thanks to Mayor Leland, Town Council, and office staff, Town Hall (405 Pinckney St) will provide a temporary location for the library.

The official start date for holds pickup resuming in McClellanville will be announced on social media and town bulletin boards. Patrons will be able to pick up their holds during Town Hall hours. The book drop will remain open at 222 Baker Street and will be checked daily; patrons may still drop off materials in the book drop or at Town Hall with McClellanville Library staff.

Storytimes will be held at the New Wappetaw Presbyterian Church in the Fellowship Hall on Tuesdays at 10:00 am. Ms. Larissa will also continue her visits to the CREECS School.

#### Invitation for bids-Town of McClellanville:

Sealed bids from qualified contractors are being accepted by the Town of McClellanville for the installation of an Engineered Septic System to serve the existing buildings at 711 Pinckney Street (formerly McClellanville Middle School).

Sealed Bids will be accepted by mail or delivery to the McClellanville Town Hall at 405 Pinckney Street; McClellanville, SC 29458 until 4:00 PM February 2, 2023. Bids will be opened at 4:30 PM and presented to Council at the monthly Town Council meeting on Monday, February 5, 2024.

**Qualifications:** Contractor must be a Tier 3, South Carolina licensed septic installer.

Project Scope: The contractor's bid shall include all materials, labor, equipment and work necessary to install an engineered septic system (1500 gpd gravel bed with low pressure distribution) as outlined in the design report by Malcolm Baldwin, PE, "Individual Wastewater System; Town of McClellanville Office Complex; 711 Pinckney Street" and dated 04/30/23. Design Report is available by email from design engineer or posted on the Town of McClellanville website. See contact information below. Note that the buildings on site are existing with existing utilities and drainage features in place. The contractor will be responsible for utility locates prior to excavation. The following is will also be included in the scope of work:

- Building A- Locate existing sewer service and tie to new solids tank. Pipe beyond connection point is to be abandoned and may remain in place.
- Building B- The existing tanks and gravity line will remain in operation. The contractor shall tie gravity line to the new pump tank.
- Building C- There currently is no bathroom facilities in this building. The contractor shall install the associate tanks and pump but no building connection will be required.
- Contractor shall install tree projection around protected trees in the immediate area of work.

## **Bid Procedure:**

- Bids may not be emailed or submitted electronically
- Bid to be in a sealed envelope with "Sealed Bid for 711
   Pinckney Street" written on the outside
- Include a copy of the contractors SC Teir 3 license
- A bid bond will not be required
- Payment and performance bond will not be required

- Include lump sum price for installation of the system as outlined in the scope
- Bid can be mailed or delivered to the McClellanville Town Hall at 405 Pinckney St, McClellanville, SC 29458
