New Fireworks Ordinance Adopted

The McClellanville Town Council recently approved a new fireworks ordinance to help balance holiday celebrations with community safety and peace of mind. This action follows a near-miss last July 4th, when fireworks nearly caused a fire at Town Hall.

Fireworks may only be discharged during limited hours on **July 4 (6-10 PM) and New Year's Eve (6 PM-1 AM)**, and only on private property with the owner's consent.

Important Restrictions:

- Fireworks are prohibited on public property, including Town Hall (405 Pinckney Street) and the Old School (711 Pinckney Street).
- No fireworks may be discharged within 500 feet of any church or gas station.
- No fireworks may be discharged within 300 feet of any school.
- Fireworks are also prohibited in designated "no-fireworks zones" and during drought or red-flag fire warnings.

Professional displays remain permitted with a Town-issued authorization. Residents are encouraged to celebrate responsibly, dispose of spent fireworks safely, and be mindful of neighbors, pets, and veterans who may be sensitive to loud noise.

Oyster Shell Recycling Location at Town Hall near Fire Tower:

Recycling Do's and Don'ts

- **DO** separate shell from trash. Shell mixed with trash is not suitable for recycling. Provide separate containers for shell and trash.
- **DO** dump shells from bags or containers and leave only shells in the bins.
- **DO** bring your shell to the nearest shell recycling center. 405 Pinckney Street—Drop-off site is on the right near the fire tower.
- **DON'T** put live oysters in South Carolina waters. If the oysters you purchased were harvested outside South Carolina, it is illegal to place them in SC waters. Placing imported oysters in our waters can create environmental problems and may harm local oysters or other animals. To avoid contamination, shell should be recycled to DNR and properly quarantined for 6 months. When shells are recycled, they can be used as estuarine filters and habitats for sea animals and help with erosion control. A single oyster alone can filter 2.1 gallons of water per hour.

Town of McClellanville Dog Pen

The Town of McClellanville Dog Pen is designated solely for the temporary holding of stray animals found within town limits. While we care deeply about every wandering or lost pet, our resources are limited. Charleston County Animal Control assists by collecting animals from the pen when requested by the Town.

If you find a stray dog or cat within McClellanville:

- Please contact Erin Browne at mcclellanvilleCE@outlook.com so that someone can meet you at the pen. This ensures the animal has food, water, and bedding during its stay.
- Because we are a small town, we make every effort to reunite pets with their rightful owners before contacting Animal Control. In most cases, these efforts are successful.
- Our priority is to return pets to the correct owner and prevent them from being placed in the wrong hands. Animal Control is contacted only after all reasonable efforts to locate the owner have been exhausted.

Important: Do not place any animal in the pen without being directed to do so. This safeguard ensures that animals are properly cared for, walked, and monitored while in our custody.

Streetlight Out? Let Us Know!

The Town of McClellanville is committed to keeping our streets safe and well-lit. If you notice a streetlight that is out, flickering, or otherwise not working properly, please contact Town Hall by phone or email so we can report the issue promptly.

Important: When reporting a streetlight problem, we will need the streetlight number. This number is located on a small metal tab attached to the pole. Providing this number ensures we can identify the exact light and have it repaired quickly.
