1. Purchase of permit does not guarantee parking availability.
2. One (1) permit per vehicle. Permit must be placed only on vehicle/tag number listed below.
3. Vehicles using the boat launching and landing facilities without a valid permit/sticker will be ticketed and a fine imposed. The Town has jurisdiction over this property.
4. Permits must be placed on the rear window on the driver's side of vehicle. All stickers must be permanently attached to the rear window and in plain view and NOT obscured in any way.
5. Vehicles without attached boat trailers are NOT permitted to park in the boat landing (gravel) parking lot, even with a boat launch permit. Vehicles will be ticketed.
6. Vehicles with attached trailers and boats are prohibited from parking along the roadsides within the Town of McClellanville. Vehicles will be ticketed.
7. Park in designated spaces only. Pull your vehicle and trailer straight into one parking space. Vehicles parked at angles that restrict the use of neighboring parking spaces and vehicle will be ticketed.
8. Keep landing area, waterways, and the Town of McClellanville litter free. (Leave no trace behind)
9. A permit will only be replaced if the old permit is returned to the town office. Otherwise, a new permit will be issued at full price. (ex. trade/sell car, replace back glass, etc. remove permit and bring in as many pieces as possible, including the permit number, for replacement.)

1. Vehicles using the boat launching and landing facilities without a valid permit/sticker will be ticketed and a fine imposed. The Town has jurisdiction over this property.
2. Stickers **must** be placed on the rear window on the driver's side of vehicle. All stickers **must be permanently attached** to the rear window and in plain view and **NOT** obscured in any way.
3. Vehicles without attached boat trailers are **NOT** permitted to park in the boat landing (gravel) parking lot, even with a boat launch permit. Vehicles will be ticketed.
4. Vehicles with attached trailers and boats are prohibited from parking along the roadsides within the Town of McClellanville. Vehicles will be ticketed.
5. Park in designated spaces only. Pull your vehicle and trailer straight into one parking space. Vehicles parked at angles that restrict the use of neighboring parking spaces and vehicle will be ticketed.
6. One (1) sticker per vehicle.
7. **Purchase of permit does not guarantee parking availability.**
8. Keep landing area, waterways, and the Town of McClellanville litter free. (Leave no trace behind)
9. A sticker will **only** be replaced if the old sticker is brought into town office. Otherwise, a new permit will be issued at full price. (ex. trade/sell car, replace back glass, etc. remove sticker and bring in as many pieces as possible, including the permit number, for replacement.)

If you have any questions about whether you qualify for resident status, or to obtain additional applications, please call the office at (843.887.3712). If you apply for a primary permit and a second permit, please be sure to enclose copies of both vehicle registrations. The decals will then be mailed to you.

If you receive a citation, you must either forfeit and pay the penalty or notify the town offices that you wish a hearing before the Magistrates Court (10009 Highway 17 N, McClellanville, SC 29458) within 10 days of the violation. Magistrates Court hears cases on the third Wednesday of the Month. **Town staff cannot modify or forgive a citation after it is issued.** Magistrates Court phone number is 843.887.3334, office hours are Monday, Wednesday, and Thursday 9 am- 12 pm, and 1 pm – 4 pm.
